The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Section 1. 32.03 (6) of the statutes is created to read:

32.03 (6) (a) In this subsection, except as provided in subd. 2. "blighted property" means any property that, by reason of abandonment, dilapidation, deterioration, age or obsolescence, inadequate provisions for ventilation, light, air, or sanitation, high density of population and overcrowding, faulty lot layout in relation to size, adequacy, accessibility, or usefulness, unsanitary or unsafe conditions, deterioration of site or other improvements, or the existence of conditions that endanger life or property by fire or other causes, or any combination of such factors, is detrimental to the public health, safety, or welfare.
