AB 47

August 17, 2005 – Introduced by Senators Carpenter and A. Lasee, cosponsored by Representatives Cullen and Berceau. Referred to Committee on Judiciary, Corrections and Privacy.

1 AN ACT **relating to:** time limits for bringing an action for sexual exploitation by a member of the clergy.

Analysis by the Legislative Reference Bureau

Under current law, a person who has been injured as the result of sexual contact by a member of the clergy must bring an action for damages resulting from that contact before the person reaches the age of 35. This bill allows a person who has been injured as the result of sexual contact by a member of the clergy at any time in the past to bring an action for damages resulting from that contact within one year after the effective date of this bill.
