ASSEMBLY AMENDMENT 2
TO 2005 ASSEMBLY BILL 709
SENATE 477

October 17, 2005 - Offered by Representative UNDERHEIM.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 3, line 17: delete lines 17 to 18 and substitute:
- 3 **"440.982 Licensure. (1)** No person may engage in the practice of midwifery
- 4 unless the person is granted a license under this subchapter, is granted a temporary
- 5 permit pursuant to a rule promulgated under s. 440.984 (2m), or is licensed as a
- 6 nurse-midwife under s. 441.15.
- 7 **(1m)** Except as provided in sub. (2), the department may grant a license to a
- 8 person under this subchapter if all of the following apply:".
- 9 **2.** Page 4, line 18: after "(2)" insert ", (2m),".
- 10 **3.** Page 4, line 23: after that line insert:
- 11 **"(2m)** The rules shall provide for the granting of temporary permits to practice
- 12 midwifery pending qualification for licensure.".
