SENATE AMENDMENT ,

TO 2005 SENATE BILL 477

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 4, line 18: delete "(2) and (3)" and substitute "(2), (2m), and (3)".

3 **2.** Page 4, line 23: after that line insert:

4 **"(2m)** The rules shall require that a licensed midwife have in effect a
5 malpractice liability insurance policy in an amount identical to the amount of
6 malpractice liability insurance required of a nurse-midwife by the board of nursing
7 under rules promulgated pursuant to s. 441.15 (5) (bm)".
