TO 2005 SENATE BILL 477

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 4, line 18: delete "(2) and (3)" and substitute "(2), (2m), and (3)".
- 3 **2.** Page 4, line 23: after that line insert:
- 4 **"(2m)** The rules shall require that the practice of a licensed midwife occur in
- 5 collaboration, as defined in s. 441.15 (1) (a), with a physician and pursuant to a
- 6 written agreement with the physician."
