

6 charged for providing state mailings, special computer services, training programs,
7 printed materials, and publications and for conducting searches under s. 48.025 (3)
8 (c), for the purpose purposes of providing state mailings, special computer services,
9 training programs, printed materials, and publications and of defraying the costs
10 specified in s. 48.025 (3) (c).

11 **SECTION 1r.** 46.03 (7) (bm) of the statutes is amended to read:"
