### *Analysis by the Legislative Reference Bureau*

This bill directs the Department of Transportation to designate and mark the bridge on STH 141 in the Town of Lena in Oconto County as the "Nicole Frye Memorial Bridge" in honor and recognition of Nicole Frye, who sacrificed her life in Operation Iraqi Freedom.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

4 SECTION 1. 84.1034 of the statutes is created to read:
