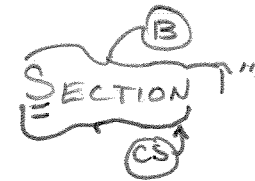
6 (2) Notwithstanding section 16.27 (5) of the statutes, in fiscal year 2005-06,
7 a household with an annual income that does not exceed 206.7 percent of the federal
8 poverty line is eligible to receive low-income energy assistance under section 16.27
9 of the statutes. Notwithstanding section 16.27 (2), (3), and (6) of the statutes, the
10 department of administration shall pay low-income energy assistance benefits
11 under this subsection from the appropriation account under section 20.505 (1) (dm)
12 of the statutes, as created by this act.

13 **SECTION 2m. Appropriation changes, health and family services.**

14 (1) MEDICAL ASSISTANCE REIMBURSEMENT DECREASE. In the schedule under
15 section 20.005 (3) of the statutes for the appropriation to the department of family
16 services under section 20.435 (4) (b) of the statutes, as affected by the acts of 2005,
17 the dollar amount is decreased by \$63,500,000 for fiscal year 2005-06 and the dollar
18 amount is decreased by \$100,000 for fiscal year 2006-07 to decrease funding for the
19 purposes for which the appropriation is made.

20 (2) TRANSFER FROM GENERAL FUND TO MEDICAL ASSISTANCE TRUST FUND. There is
21 transferred from the general fund to the Medical Assistance trust fund \$51,400,000
22 in fiscal year 2005-06 and \$25,300,000 in 2006-07.
