This bill requires each appointing authority of an agency in the executive branch of state government to conduct a criminal history background investigation of an applicant for a position, the duties of which include access to funds administered by a state agency, before offering that applicant employment in the position.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
