3 "SECTION 1m. 24.09 (1) (a) of the statutes is amended to read:

4 24.09 (1) (a) Except as provided under par. (c), the board may not sell or
5 exchange any public lands which were not appraised or appraised under s. 24.08.
6 Except as provided under pars. (b), (bm) and (c), the board may not sell or exchange
7 any public lands except at public auction or by sealed bid."

8 2. Page 5, line 25: after "taxes" insert "from appropriate trust fund incomes".
