4 "SECTION 1g. 46.284 (4) (d) of the statutes is amended to read:

5 46.284 (4) (d) Provide or contract for the provision of necessary services and
6 monitor the provided or contracted services. Any entity under this paragraph that
7 provides services shall directly employ, or contract with the county to employ, county
8 employees to provide the direct services."
