

AMENDMENT TO SUBSTITUTE AMENDMENTS 657/3 AND 665/2
TO ASSEMBLY BILL 1110 AND SENATE BILL 653

Motion:

Move to amend the substitute amendment to:

1. Specify that the Department's responsibility to conduct ongoing evaluations of the long-term care system, as provided in Section 13 of the substitute amendment, would be limited to medical assistance-funded long-term care programs that are provided through managed care.
2. Require Family Care care management organizations to increase payments to nursing homes to reflect nursing home rate increases and supplemental payments authorized under 2005 Wisconsin Act 211.

1 At the locations indicated, amend the substitute amendment as follows:

2 ✓ 1. Page 1, line 9: delete "and long-term care".

3 ✓ 2. Page 1, line 10: after "evaluations" insert "of certain managed care
4 programs for provision of long-term care services, and requiring increased payment
5 to nursing homes for care provided as a Family Care benefit".

6 ✓ 3. Page 8, line 15: delete "the long-term care system" and substitute "the
7 long-term care system".

8 ✓ 4. Page 8, line 16: after "46.2895" insert "managed care programs for provision
9 of long-term care services that are funded by medical assistance, as defined in s.
10 46.278 (1m) (b).".

11 ✓ 5. Page 10, line 8: after that line insert:

① **SECTION 19. Nonstatutory provisions.**

2 (1) INCREASED PAYMENTS FOR NURSING HOMES PROVIDING FAMILY CARE BENEFIT
3 SERVICES.

4 (a) In this subsection:

5 1. "Care management organization" has the meaning given in section 46.2805
6 (1) of the statutes.

7 2. "Facility" has the meaning given in section 49.45 (6m) (a) 3. of the statutes.

8 3. "Family Care benefit" has the meaning given in section 46.2805 (4) of the
9 statutes.

10 4. "Medical Assistance" has the meaning given in section 46.278 (1m) (b) of the
11 statutes.

12 (b) Care management organizations shall provide increased funding for
13 reimbursement for care provided by facilities for recipients of Medical Assistance as
14 a Family Care benefit, in amounts that proportionately reflect all of the following:

15 1. For fiscal year 2005-06, the nursing home reimbursement supplement
16 authorized under 2005 Wisconsin Act 211, Section 1 (4d).

17 2. For fiscal year 2006-07, the nursing home reimbursement rate increase
18 authorized under 2005 Wisconsin Act 211, Section 1 (4c)."
