TO ASSEMBLY SUBSTITUTE AMENDMENT 2 ✓

March 9, 2006 - Offered by Senator CARPENTER.

At the locations indicated, amend the bill as follows:

1. Page 1, line 6: after "organizations" insert "or to provide services".

2. Page 2, line 1: before that line insert:

"SECTION 1g. 19.82 (1) of the statutes is amended to read:

19.82 (1) "Governmental body" means a state or local agency, board, commission, committee, council, department or public body corporate and politic created by constitution, statute, ordinance, rule or order; a governmental or quasi-governmental corporation except for the Bradley center sports and entertainment corporation; a local exposition district under subch. II of ch. 229; a family care district under s. 46.2895; an entity that contracts under s. 46.284 (4) (d) to provide services, for the period of the contract; a nonprofit corporation operating the Olympic ice training center under s. 42.11 (3); or a formally constituted subunit of any of the foregoing, but excludes any such body or committee or subunit of such

3 **3.** Page 2, line 1: delete “SECTION 1” and substitute “SECTION 1r”.

4 **4.** Page 6, line 20: after that line insert:

5 “SECTION 13m. 46.284 (4) (d) of the statutes is amended to read:

6 46.284 (4) (d) Provide or contract for the provision of necessary services and
7 monitor the provided or contracted services. An entity that enters into a contract
8 under this paragraph shall agree, as part of the contract, that during the period of
9 the contract the financial records and service plan of the entity are available, as
10 specified in s. 19.36 (3), except as provided in ss. 19.35 (1) (am) and 19.36 (12). Such
11 an entity shall also agree to be subject to subch. V of ch. 19 during the period of the
12 contract.”.
