

TO 2005 ASSEMBLY BILL 534

Page 2, line 22: delete "(c) 3." and substitute "(c) 2."

1 At the locations indicated, amend the bill, as shown by assembly substitute
2 amendment 1, as follows:

3 1. Page 2, line 11: after "fund" insert "and the amount due to a municipality
4 under par. (c) 5."

5 2. Page 4, line 2: after that line insert:

6 "4. Notwithstanding subd. 3, if the department sells a land parcel under subd.
7 2. to a municipality that contributed funds for the purchase of the property when the
8 property was acquired by the department, the department shall sell the property to
9 the municipality for the market price less the percentage ^{that} the municipality
10 contributed to the total price paid for the property by the department.

11 5. If the department sells a land parcel under subd. 2 to a local school district
12 or the department of natural resources or at a public sale, the department shall pay
13 any municipality that contributed funds for the purchase of the property when the

1 property was acquired by the department a percentage of the sale price that is equal
