

Subject: LTE Residency Requirements – Minor Children of Divorced Parents

Please draft a 2003 Assembly Bill that will accomplish the following:

- Under Wis. Stats. 230.26 and 230.27, an individual must be a "resident of this state" to be eligible for LTE or project positions in state government. "Resident of this state" is defined in 230.03 (12).
- Please change the definition of "resident of this state," for the purposes of Chapter 230, to include a minor child, where one or both of that minor child's parents is a resident of this state. Alternatively, if it is more in accordance with drafting procedures, I would be comfortable with notwithstanding the residency requirement for this group as well. Also, please make any other necessary changes in current law that may be necessary to permit this.
- My intent is to allow children in divorced/separated families who may only have regular visitation with their parent in Wisconsin, and thereby are technically residents of another state, to be eligible for state LTE and project positions.

Analysis by the Legislative Reference Bureau

Current law provides that under the state civil service system a limited term or project position may not be filled by a person who is not a resident of this state. Limited term appointments are provisional appointments for less than 1,044 hours, project position appointments may not be for more than 4 years. This bill provides that a minor child of a person who is a resident of this state is a resident of this state for purpose of appointment to a limited term or project position.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
