

With the Kaufert amendment, I think the changes to the county placement provisions (other than the Chapter 980 guys) need to be added (e.g. deleting the 1st class city references). Those changes would be identical to Lazich's sub. Also, for the provision on passive GPS tracking, I'd make the following change: on page 1, line 11 after "decide" delete the remaining part of the sentence and replace it with "to utilize passive positing system tracking instead of lifetime tracking."

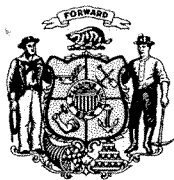
