# ASSEMBLY AMENDMENT, TO SENATE SUBSTITUTE AMENDMENT 2, TO 2005 ASSEMBLY BILL 591

At the locations indicated, amend the substitute amendment as follows:

1. Page 20, line 13: after "residence" insert "As a condition of supervised release, no person may reside within 1,000 feet of any state, county, city, village, or town park; a multiunit public housing project; a swimming pool open to members of the public; a child care facility operated by a person licensed under s. 48.65 or 48.69 or certified under s. 48.651 or that is established or contracted for under s. 120.13 (14); a youth center; a community center; or any private or public school premises".
