

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 1, line 10: after "children," insert "grants to nonprofit organizations
- 3 providing services to victims of sexual assault,".
- 4 **2.** Page 3, line 1: before that line insert:
- 5 "SECTION 1g. 16.964 (11) of the statutes is created to read:
- 6 16.964 (11) From the appropriation under s. 20.505 (6) (gj), the office shall
- 7 provide grants to nonprofit organizations that provide services to victims of sexual
- 8 assault. The office may use up to 10 percent of the amount appropriated to cover the
- 9 costs of administering the grant program. The office shall develop criteria and
- 10 procedures for use in selecting grantees and administering the grant program.
- 11 Notwithstanding s. 227.10 (1), the criteria and procedures need not be promulgated
- 12 as rules under ch. 227."
- 13 **3.** Page 3, line 1: delete "SECTION 1" and substitute "SECTION 1r".
