ASSEMBLY AMENDMENT, TO 2005 ASSEMBLY BILL 856



1 At the locations indicated, amend the bill as follows:

1. Page 2, line 7: after that line insert:

"Section 1m. 66.1113 (2) (b) of the statutes is amended to read:

66.1113 (2) (b) Subject to pars. (g) and (h), a political subdivision that is a premier resort area may impose the tax under s. 77.994.

Page 2, line 12: after "retailers." insert "The village may not impose the tax authorized under par. (b) unless the village board adopts a resolution proclaiming its intent to impose the tax and the resolution is approved by a majority of the electors in the village voting on the resolution at a referendum, to be held at the first spring primary or election or September primary or general election following by at least 45 days the date of adoption of the resolution.".

3. Page 3, line 2: after "retailers." insert "The village may not impose the tax authorized under par. (b) unless the village board adopts a resolution proclaiming its

intent to impose the tax and the resolution is approved by a majority of the electors
in the village voting on the resolution at a referendum, to be held at the first spring
primary or election or September primary or general election following by at least 45
days the date of adoption of the resolution.".
