

Here is the language that we discussed for AB 1186:

The Department of Commerce shall analyze and study the effect of this bill on the existing Wisconsin businesses community, the potential impact on the creation and growth of Wisconsin businesses, and, in general, the impact on Wisconsin's economy. The Department of Commerce shall, by July 1, 2007, report the results of this study to both houses of the legislature. The effective date of the bill would be moved to January 1, 2008.

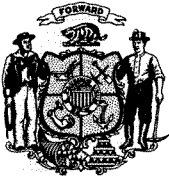

At the locations indicated, amend the bill as follows:

1. Page 163, line 17: delete lines 17 to 19 and substitute:

"SECTION 114m. Nonstatutory provisions.

(1) Not later than July 1, 2007, the department of commerce shall submit to the legislature under section 13.172 (2) of the statutes a report analyzing the effect of this act ^{will have} on the businesses community in this state, on the creation and growth of businesses in this state, and on the economy of this state in general.

that

SECTION 115^m. Effective dates. This act takes effect on January 1, 2008, except as follows:

(1) SECTION 114m of this act takes effect on the day after publication."
