2 **1.** Page 2, line 5: after that line insert:

3 **"SECTION 2.** 71.935 (1) (am) of the statutes is created to read:

4 71.935 (1) (am) "Debt related to property taxes" means delinquent general property
5 taxes as defined ⁱⁿ under s. 74.01 (1), special assessments as defined ⁱⁿ under s. 74.01 (3), special
6 charges as defined ⁱⁿ under s. 74.01 (4), and special taxes as defined ⁱⁿ under s. 74.01 (5). The term
7 includes any interest and penalty charged as a result of ~~the~~ delinquency."
