 alteration from the department.

4 (b) *Application.* A person applying for a permit under par. (a) shall include, 5 along with the application, copies of specifications and accurately scaled and fully 6 dimensioned plans showing the location of the construction, installation, or 7 alteration in relation to the plans and elevation of the building; the location of the 8 applicable machinery room, if any, and the equipment to be constructed, installed, 9 or altered; and all structural supporting members relevant to the construction, 10 installation, or alteration, including foundations. (a) *Permit required.* No person may allow a conveyance to be 8 operated on property owned by the person unless the person has received a permit 9 for the operation from the department. The department may not issue a permit 10 required under this paragraph until all inspections required under par. (c) are 11 completed.

(b) *Application.* For a newly installed conveyance, the elevator contractor that
contracted to perform the installation shall apply for the initial permit required
under par. (a) on behalf of the owner of the building in which the conveyance is
located. Applications for renewal of the permit shall be made by the owner.

16 (c) *Inspections.* The department may not issue or renew a permit under this 17 subsection unless the department has received an inspection report for the 18 conveyance issued by an elevator inspector licensed under s. 101.985 (3) indicating 19 that the conveyance complies with this subchapter and any applicable rules 20 promulgated under this subchapter. Upon request of the owner of a private residence 21 containing a newly installed platform lift, stairway chair lift, or residential lift or of 22 the new owner of a private residence containing a previously installed platform lift, 23 stairway chair lift, or residential lift, the department shall inspect the lift or 24 equipment for compliance with this subchapter and any applicable rules 25 promulgated under this subchapter. 6 (d) *Term and posting requirements.* A permit issued under this subsection has 7 a term of one year, except that a permit applicable to a platform lift, stairway chair 8 lift, or residential lift in a private residence is valid until ownership of the private 9 residence is transferred, at which time the new owner shall apply for renewal of the 10 permit under par. (b). The owner of the building or residence in which a conveyance 11 is located shall display the permit under par. (a) applicable to the conveyance on or 12 in the conveyance or, if applicable, in the machinery room.

13 101.984 Licenses and supervision required. (1) ELEVATOR CONTRACTOR.
14 No person may engage in the business of constructing, installing, altering, servicing,
15 replacing, or maintaining conveyances in this state unless the person is licensed as

17 (2) ELEVATOR MECHANIC. (a) *Generally.* Except as provided in par. (c), no
18 individual may erect, construct, alter, replace, maintain, repair, remove, or
19 dismantle any conveyance in this state unless the individual is licensed as an
20 elevator mechanic under s. 101.985 (2) and is or is under the direct supervision of a
21 person licensed as an elevator contractor under s. 101.985 (1).

(b) *Electrical construction.* Except as provided in par. (c), no individual may
wire any conveyance in this state from the mainline feeder terminals on the
controller unless the individual is licensed as an elevator mechanic under s. 101.985

(2) and is or is under the direct supervision of a person licensed as an elevator
 contractor under s. 101.985 (1).

3 (c) *Exceptions.* 1. Paragraph (a) does not apply to an individual who removes
4 or dismantles a conveyance that is destroyed as a result of a complete demolition of
5 a building or where the hoistway or wellway is demolished back to the basic support
6 structure such that the hoistway or wellway is inaccessible.

2. Paragraphs (a) and (b) do not apply to any of the following:

a. An individual who is enrolled in and performing tasks that are within the
scope of an elevator mechanic's apprenticeship program that is approved by the U.S.
department of labor.

20 **101.985 Licensing qualifications and procedure. (1)** ELEVATOR 21 CONTRACTOR. Except as otherwise provided in this subsection, the department shall 22 issue an elevator contractor's license to each person who demonstrates to the 23 satisfaction of the department that the person is adequately qualified and able to 24 engage in business as an elevator contractor. The department may summarily issue 25 an elevator contractor's license to a person who is licensed as an elevator contractor

1 under the laws of another state, if, in the opinion of the department, that state's 2 regulation of elevator contractors is substantially the same as this state's. During the 3 years preceding the date of application, was continuously 17 employed in a position requiring the individual to perform work that is at a 18 journeyman level and that is relevant to the erection, construction, alteration, 19 replacement, maintenance, repair, removal, or dismantling of conveyances, as 20 verified by the individual's employers.

3. Satisfactorily completes a written examination administered by the
department covering the provisions of this subchapter, and rules promulgated under
this subchapter, that are relevant to the license applied for or satisfactorily
completes an elevator mechanic's examination approved by the department and

administered by a nationally recognized training program established by the
 elevator industry.

3 4. Satisfactorily completes an elevator mechanic's apprenticeship program4 that is approved by the U.S. department of labor.

(am) *Requirements for individuals with prior experience.* The department shall
promulgate rules that establish requirements for issuing elevator mechanic's
licenses to individuals who have performed work described under s. 101.984 (2) (a)
or (b) within the scope of their employment before the effective date of this paragraph
.... [revisor inserts date], but who do not satisfy all of the criteria specified in par. (a)
to 4. The rules may contain a deadline before which an individual must apply for
a license issued under this paragraph.

12 (b) *Licensing out-of-state mechanics.* The requirements under par. (a) 1. to 4. 13 do not apply to an individual who is licensed as an elevator mechanic under the laws 14 of another state, if, in the opinion of the department, that state's regulation of 15 elevator mechanics is substantially the same as this state's. The department may 16 summarily issue an elevator mechanic's license to such an individual.

17 (c) *Emergency licensing.* If the governor declares that a state of emergency 18 exists in this state under s. 166.03 (1) (b) 1. and the department determines that the 19 number of individuals in the state who hold elevator mechanic's licenses issued by 20 the department under this section on the date of the declaration is insufficient to cope 21 with the emergency, the department shall summarily issue an emergency elevator 22 mechanic's license to any individual who is certified by an elevator contractor 23 licensed under this subchapter as adequately qualified and able to perform the work 24 of an elevator mechanic without direct and immediate supervision, who the 25 department determines is so qualified and able, and who applies for an emergency 1 elevator mechanic's license on a form prescribed by the department. An individual 2 certified by a contractor under this subdivision may perform work as an elevator 3 mechanic for up to a total of 5 days preceding the date the individual is issued the 4 license. An emergency elevator mechanic's license has a term of 30 days and may be 5 renewed by the department in the case of a continuing emergency. The department 6 shall specify on an emergency elevator mechanic's license the geographic area in 7 which the licensee may provide services under the license. The requirements under 8 par. (a) 1. to 4. do not apply to an individual who applies for an emergency elevator 9 mechanic's license.

10 (d) *Temporary licensing*. If there are no elevator mechanics licensed under this 11 subchapter available to provide services contracted for by an elevator contractor 12 licensed under this subchapter, the elevator contractor may notify the department 13 and request the issuance of a temporary elevator mechanic's license to any individual 14 who is certified by the elevator contractor as adequately qualified and able to perform 15 the work of an elevator mechanic without direct and immediate supervision and who 16 applies for a temporary elevator mechanic's license on a form prescribed by the 17 department. A temporary elevator mechanic's license has a term of 30 days and may 18 be renewed by the department in the case of a continuing shortage of licensed 19 elevator mechanics. The department shall specify on a temporary elevator 20 mechanic's license the elevator contractor in whose employ the licensee must remain 21 to provide services under the temporary elevator mechanic's license. The 22 requirements under par. (a) 1. to 4. do not apply to an individual who applies for a 23 temporary elevator mechanic's license.

24 (3) ELEVATOR INSPECTOR. The department shall issue an elevator inspector
25 license to each individual who demonstrates to the satisfaction of the department

that the individual is adequately qualified and able to provide elevator inspection
 services. The department shall promulgate rules that establish the qualifications
 required for issuance of an elevator inspector license.

4 (4) CRIMINAL BACKGROUND CHECK. Upon receipt of an application for a license 5 under sub. (1), (2) (a), or (3), the department, with the assistance of the department 6 of justice, shall conduct a background investigation of the applicant to determine if 7 the information provided by the applicant under sub. (7) (a) 10. is true and if 8 applicant has any arrests or convictions tending to indicate that the applicant is not 9 adequately qualified and able to provide services authorized under the license 10 applied for.

(5) ISSUANCE, TERM, RENEWAL, AND CONTINUING EDUCATION. (a) *Issuance and term.*Except as provided under s. 101.02 (20) (b) and (21) (b), the department shall issue

The notice shall set forth the specific grounds for the request 10 and shall be signed by the person filing the notice. Upon request of the person filing 11 the notice, the department shall keep the person's name confidential and shall 12 withhold the name from public inspection under s. 19.35 (1), except that the 13 department may disclose the name to a law enforcement officer for official purposes. 14 If the department determines that there are reasonable grounds to believe that the 15 alleged violation or dangerous condition exists, the department shall investigate to 16 determine if the alleged violation or dangerous condition exists. If the department 17 determines that there are no such reasonable grounds, the department shall notify 18 the person filing the notice.

(2) ORDERS OF THE DEPARTMENT. The department may issue orders to enforce 20 this subchapter and rules promulgated under this subchapter.

21 (3) PENALTIES. Any person who violates this subchapter or rules promulgated 22 under this subchapter may be fined not more than \$1,500 or imprisoned for not more 23 than 30 days or both, except that, notwithstanding s. 939.61 (1), the owner of a 24 private residence in which a conveyance is located may not be fined or required to 25 pay a forfeiture to this state as a result of any violation involving that conveyance.

Using the procedure under section 227.24 of the statutes, 13 the department of commerce shall promulgate as emergency rules the rules required 14 under subchapter VII of chapter 101 of the statutes, as created by this act, and under 15 section 101.19 (1) (k) of the statutes, as created by this act. Notwithstanding section 16 227.24 (1) (c) and (2) of the statutes, the emergency rules promulgated under this 17 subsection may remain in effect until the date on which the permanent rules 18 required under subchapter VII of chapter 101 of the statutes, as created by this act, 19 and under section 101.19 (1) (k) of the statutes, as created by this act, take effect. 20 Notwithstanding section 227.24 (1) (a) and (3) of the statutes, the department of 21 commerce is not required to provide evidence that promulgating rules under this 22 subsection as emergency rules is necessary for the preservation of the public peace, 23 health, safety, or welfare and is not required to provide a finding of emergency for the 24 rules promulgated under this subsection. The department of commerce shall 1

promulgate the rules required under this subsection no later than the first day of the 9th month beginning after the effective date of this subsection.

3 (3) EFFECT ON COLLECTIVE BARGAINING AGREEMENTS. If a person is affected by a 4 collective bargaining agreement that is in effect on the effective date of this 5 subsection and that contains provisions that are inconsistent with subchapter VII of chapter 101 of the statutes, as created by this act, then, notwithstanding 6 7 subchapter VII of chapter 101 of the statutes, as created by this act, the person may 8 perform its obligations, and exercise its rights, under those provisions of the 9 collective bargaining agreement until the collective bargaining agreement expires 10 or is extended, modified, or renewed, whichever occurs first.

11 (4) INITIAL MEMBERS OF CONVEYANCE SAFETY CODE COUNCIL. Notwithstanding the 12 length of terms specified for the conveyance safety code council under section 15.157 13 (14) (a) of the statutes, as created by this act, the initial members appointed under 14 section 15.157 (14) (a) 1. to 3. of the statutes, as created by this act, shall be appointed 15 for terms that expire on July 1, 2007, the initial members appointed under section 16 15.157 (14) (a) 4. and 5. of the statutes, as created by this act, shall be appointed for 17 terms that expire on July 1, 2008, and the initial members appointed under section 18 15.157 (14) (a) 6. to 8., as created by this act, shall be appointed for terms that expire 19 on July 1, 2009.

(5) GRACE PERIOD FOR OBTAINING PERMIT TO OPERATE EXISTING CONVEYANCES.
Notwithstanding section 101.983 (2) of the statutes, as created by this act, the owner
or lessee of any conveyance, as defined in section 101.981 (1) (c) of the statutes, as
created by this act, in operation on the effective date of this subsection shall obtain
the permit required under section 101.983 (2) of the statutes, as created by this act,
no later than the first day of the 6th month beginning after the effective date of this

subsection. This subsection does not apply to any person required to obtain a permit
 under rules of the department of commerce that are in effect before the effective date
 of this subsection.
 SECTION 8. Effective dates. This act takes effect on the first day of the 12th
 month beginning after publication, except as follows:
