

Hi Joe,

Senator Roessler would like an amendment drafted to her airport development zone bill to make it a pilot program (trying to bring down cost). She thought a pilot of 1-2-3 (letting Commerce decide how many) might be a good approach to bringing down the fiscal on the bill. The fiscal estimate assumes 20 projects a year at \$1.8 million each - so if we limit it down to a pilot of 1-3 projects that should bring down the fiscal impact but provide a start of airport economic Development projects. I assume you also received the technical memo from Revenue. We are fine with this modification to the bill as well so it can be included in the amendment/sub draft.

Thanks Joe for all your help on this issue. Do you know how long it will take to get this drafted? Senator Roessler wants a hearing on the bill soon but I think it best we have the amendment language prior to that so she can decide if she wants to distribute and speak to at the hearing.

**SENATE AMENDMENT ,  
TO 2005 SENATE BILL 136**

*in 4-7-05*  
*due Fri. 4-8 AM*

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 16, line 21: after that line insert:
- 3 “(d) The department may not designate more than 3 areas as airport
- 4 development zones.”.
- 5 **2.** Page 19, line 23: delete that line and substitute: “on January 1 of the year
- 6 in which this subsection takes effect, except that if this subsection takes effect after
- 7 July 31 the treatment of sections 71.07 (2dm) (a) 1. and 3., (f) 1., (j), and (k) and (2dx)
- 8 (a) 2., (b) (intro.), (c), and (d), 71.28 (1dm) (a) 1. and 3., (f) 1., (j), and (k) and (1dx) (a)
- 9 2., (b) (intro.), (c), and (d), and 71.47 (1dm) (a) 1. and 3., (f) 1., (j), and (k) and (1dx)
- 10 (a) 2., (b) (intro.), (c), and (d) of the statutes first applies to taxable years beginning
- 11 on January 1 of the year following the year in which this subsection takes effect.”.
