Assumptions Used in Arriving at Fiscal Estimate

BILL SUMMARY:

Current law requires that whenever a court or judge suspends or revokes an operating privilege, whenever a law enforcement officer determines a driver is operating with a prohibited alcohol concentration, or when a driver refuses the officer's request to submit to chemical testing required, they should immediately take possession of the driver license. This bill removes language mandating a court, judge, or law enforcement officer to take possession of a driver license in the course of other proceedings or actions, but gives the court the option to pick up the license if they wish to do so. If the court does seize the license, they must destroy it rather than returning it to the department.

COST SUMMARY:

Ongoing Savings: \$469 annually from document shredding

BASIS FOR COST ITEMS:

Estimate based on actual shredding costs from fiscal year 2004.

LOCAL IMPACT:

This bill could result in shredding costs to the courts that choose to continue seizing licenses.
