Assumptions Used in Arriving at Fiscal Estimate

The proposed bill will allow the surviving spouse of a person who is affiliated with a branch of the armed services or has another military affiliation with specialized vehicle registration plates may request that the plate be personalized, modify any personalization on the plate, or request the personalization plate be replaced with a regular plate.

Under current law, the surviving spouse may request that the Department of Transportation (DOT) grant permission to retain the plate. For other personalized registration plates, the surviving spouse would pay a \$15 fee for personalizing plates or modifying the existing personalization that is in addition to the costs of registering his/her vehicle with DOT.

The proposed bill will not have any fiscal effect on the department.
