I am submitting, as required by s. 253.115 of the Wisconsin Statutes, the Department's annual report on the status of Universal Newborn Hearing Screening (UNHS) in Wisconsin. I am pleased to note that in 2004 Wisconsin hospitals have exceeded the legislative directive that at least 88% of all deliveries be performed in hospitals with a UNHS program. In 2004, 99.9% of all Wisconsin babies were born in hospitals with a universal newborn hearing screening program. Including children born at home, 96.3% of all Wisconsin newborns were screened for hearing disorders in 2004.
