



2005 ASSEMBLY BILL 931

January 24, 2006 - Introduced by Representative ALBERS. Referred to Joint Committee on Finance.

1 **AN ACT to repeal** 20.435 (4) (c); and **to create** 20.435 (4) (c) of the statutes;
2 **relating to:** payments to certain nursing homes and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill creates an appropriation of general purpose revenues from which the Department of Health and Family Services must pay moneys, in fiscal year 2005-06, to certain nursing homes in certain amounts, as specified in the bill.

11 (this act), is repealed.12 **SECTION 4. Nonstatutory provisions.**13 (1) NURSING HOME PAYMENTS. From the appropriation under section 20.435 (4)
14 (c) of the statutes, as created by this act, the department of health and family services
