FORFEITURES

OVERVIEW

A forfeiture is a fiscal penalty that may be taken by the Department [delegated to, and hereafter referred to, as the Bureau of Regulation and Licensing (BRL)] against a licensee or any other person (i.e., an unlicensed provider) who violates a provision of licensure under s. 48.70(1), Wis. Stats., or rule promulgated by the Department under s 48.67, Wis. Stats. The authority to impose such a penalty is provided under s. 48.715(3), Wis. Stats. Forfeitures may be assessed in amounts of \$10 to \$1000 per day, per violation. For more information about assessing forfeiture against an unlicensed provider, see the chapter titled, Complaint Investigation – Unlicensed Facilities, in the section titled, Investigations.

In 1992 Wisconsin Act 275 authorized the Department to apply intermediate enforcement actions, sanctions (orders) and penalties (forfeitures), to licensed child day care centers. In 1994, Wisconsin Act 375 extended this authorization to licensed children's residential facilities (child care institutions, group foster homes, shelter care facilities) and child placing agencies and community based residential facilities for adults.

The Legislature enacted additional legislation in the 1995-97 budget, Wisconsin Act 27, that expanded the Department's authority to assess an immediate (direct) forfeiture without a preceding order. This authorization applies to licensed children's day care and residential facilities, child placing agencies and community based residential facilities for adults.

By authorizing the use of intermediate enforcement actions, the statutes afford the Department more options with which to address violations of licensing requirements before resorting to license revocation. Through the use of sanctions and penalties, the Department can compel licensed licensees to correct serious violations and come into compliance with minimum regulatory requirements.

The licensing chief/deputy/deputy must authorize the decision to assess a forfeiture(s) and the forfeiture(s) amount(s).

Forfeiture may be assessed:

- As a consequence of failure to comply with orders issued under s.46.715, Wis. Stats.;
- Directly without prior orders (orders may be issued together with a direct forfeiture);
- or,
- As part of a stipulation.

Forfeitures are subject to an administrative hearing as provided for in s. 227.44, Wis. Stats. The BRL is required by s. 48.715(2), Wis. Stats. to provide written notice of the grounds for forfeiture, an explanation of the type(s) of penalties imposed and an explanation of the process for appealing the forfeiture. When a licensee appeals forfeiture, payment is suspended pending the outcome of the administrative hearing.

Unless appealed, forfeiture must be paid within 10 days after the licensee receives the Notice of Forfeiture Assessment. Forfeitures are paid to the BRL central office and ultimately are deposited in the State School Fund. Failure to pay a forfeiture may result in loss of licensure.

The Notice of Forfeiture Assessment, and any associated orders, must be displayed by day care licensees beside their license in accordance with s. 48.657(2g), Wis. Stats., until such time as the BRL informs the licensee that the notice can be removed. There is no current statutory requirement for child welfare program licensees to display the Notice of Forfeiture Assessment and any associated orders.

PROCEDURES

1. Making the Decision to Assess a Forfeiture

A forfeiture may be imposed in the following circumstances:

- Most commonly, as the next enforcement step after an order has been issued and a follow-up inspection verifies that the order has not been complied with by the specified time, or has been violated;
- As a direct forfeiture, an enforcement action is assessed immediately for an identified non-compliance not associated with previously issued orders. A direct forfeiture is issued in the most severe circumstances where the health, safety and welfare of children in care are threatened. Usually, an order to address the non-compliance are issued with the direct forfeiture. In some cases, orders may not be issued because the non-compliance has been corrected or the circumstance is not likely to occur again;
- As part of a stipulation.

Assessing a forfeiture is a serious enforcement step. The licensing specialist must discuss the reason(s) with the licensing chief/deputy. In some situations, the licensing chief/deputy may decide to hold an informal meeting with the licensee in an attempt to resolve the compliance issue(s) without resorting to forfeiture. Should the licensing chief/deputy determine that a forfeiture is appropriate, s/he must make the Bureau's compliance specialist aware of the matter prior to proceeding with the forfeiture when:

- The situation is particularly sensitive due to the extent or serious nature of the non-compliance, i.e., there has been harm to a child; or
- There is reasonable certainty that the forfeiture will be appealed; or
- Stronger enforcement action may be necessary.

The compliance specialist will involve the bureau director and/or the Office of Legal Counsel (OLC), as appropriate.

2. Setting Forfeiture Amounts

After determining the need to proceed with assessing a forfeiture, the licensing chief/deputy, in conjunction with the licensing specialist, must determine the amount of the forfeiture to be assessed for each rule violation. The BRL is given the authority under s. 48.715(3), Wis. Stats., to assess forfeiture amounts of \$10 to \$1000 per day, per violation. The maximum forfeiture is reserved for severe circumstances that threaten the health and safety of children. Direct forfeitures tend to be higher amounts.

Forfeitures that are part of a stipulation may be negotiated and fall outside of these general guidelines.

The licensing chief/deputy and specialist must evaluate each situation individually and consider all mitigating circumstances when assessing a forfeiture(s). The following factors should be considered when setting the amount of each forfeiture.

- The severity of the violation(s) as it impacts on the health, safety and welfare of children;
- The number of children who are affected by the violation;
- Actual harm versus risk of harm to children;
- A systemic vs. an isolated incident;
- The response to the incident, such as the corrective action measures taken; whether the incident was reported to the Department; whether and how staff were disciplined, if warranted; and whether training or other instruction was initiated to prevent future occurrences of the violation;
- A history of prior violations;
- A history of prior orders or forfeiture action for similar violations;
- Mitigating factors such as significant, but not complete, correction of violations (for example, records which have been substantially, but not completely corrected and updated, or a fence which is three-quarters erected);
- The good faith effort devoted to attempts to correct the violations; and
- The financial benefit to the facility resulting from continued non-compliance.

An additional factor that might be considered when determining the amount of forfeitures for less significant violations is:

- The fiscal impact of the forfeiture in relationship to the size and type of the facility; i.e., a smaller forfeiture may ensure compliance in a small scale facility while in a very large facility, a smaller forfeiture would have little impact.

A licensing chief/deputy must approve all forfeiture amounts and notices before they are sent out. At the chief/deputy's discretion, the chief/deputy may obtain information from the BRL office manager regarding forfeiture amounts that have been

assessed throughout the state for specific violations. **The licensing chief/deputy must discuss the case with the compliance specialist if the proposed forfeiture amount exceeds \$500 total.**

3. Drafting the Notice of Forfeiture Assessment

After determining the need for assessing a forfeiture and determining the amount, the licensing specialist drafts the Notice of Forfeiture Assessment (and orders, if applicable) utilizing the appropriate standardized format available on the Department's Intranet site. **See Attachment 1., 2. and 3.** for sample copies of these notices. The available standardized formats are:

1. Notice of Forfeiture Assessment and Appeal Process
2. Notice of Direct Forfeiture Assessment and Appeal Process
3. Notice of Order to Stop Violating Statute and/or Administrative Rules,
Notice of Direct Forfeiture Assessment and Appeal Process

The standardized formats contain the statutorily required notice language; however, the unique case detail and correct rule violations must be added. Special attention must be given to drafting the notice so that the reason(s) for the enforcement action is clearly articulated. It is critical to include all violations that are the basis for the action as it is impossible to prove something at a possible later hearing that is not alleged in the notice. The licensing specialist must ensure that:

- Violation(s) of the law/rule occurred, or, the licensee failed to comply with an order;
- All facts of the violation are accurately and concisely documented, including dates, times and locations;
- The correct rule citation(s) is used to describe the violation(s); and
- The amount of the forfeiture(s) is commensurate with the violation(s).

The licensing specialist gives the draft notice and all supporting documents including a copy of the orders, if applicable, to the licensing chief/deputy for review.

The chief/deputy is responsible for the final review of the forfeiture notice to ensure that the elements listed above are included and complete and accurate. The licensing chief/deputy then signs the final Notice of Forfeiture Assessment on behalf of the bureau director.

4. Delivering the Notice of Forfeiture Assessment

The licensing specialist or other assigned staff person makes three copies of the signed notice and all supporting documentation. The original is mailed via certified mail or hand delivered to the licensee. If hand delivered, the licensing specialist must obtain the appropriate signature on the Delivery of Document Receipt. **See Attachment 4.** The certified mail delivery date receipt, or the Bureau's Receipt of Delivery form, is placed in the facility file.

Copies of the signed Notice of Forfeiture Assessment and Appeal Process are immediately distributed to the:

- Licensing specialist for placement in the facility file;
- Licensing chief/deputy;
- Central office manager.

5. Forfeiture Payment Process

Unless appealed, a forfeiture must be paid within ten days after the licensee receives the notice of the assessment in accordance with s. 48.715(3)(a)3, Wis. Stats.

In unusual instances, the licensee may request to make installment payments. The licensing specialist must obtain the licensing chief/deputy's approval to authorize installment payments and must draft an agreement outlining the amounts and due dates for installments. The BRL office manager will assist with drafting the agreement, if necessary. The first payment is due on the original forfeiture payment date. This agreement must be signed by the licensing specialist and the licensee and be placed in the facility file. A copy must be forwarded to the BRL office manager.

The BRL office manager monitors the forfeiture payment collection process in central office.

The BRL office manager is informed when a forfeiture is appealed. The licensing chief/deputy, however, must immediately notify the office manager of other events that affect the forfeiture payment, such as:

- The licensee surrenders the license;
- The payment due date changes; for example, due to difficulty in delivering the Notice of Forfeiture Assessment and Appeal Process;
- The forfeiture will be paid through installment payments;
- The forfeiture will not be paid as some other payment conditions have been authorized. Note: this only applies as a result of due process. (See 6.1. below.)

When the copy of the Notice of Forfeiture Assessment and Appeal Process is received in central office, the BRL office manager enters information into a database designed to monitor the receipt of payments.

If the ten day payment deadline passes without receipt of payment, the BRL office manager notifies the licensing specialist that the payment was not received timely and may also request additional help from the licensing specialist to ensure that the forfeiture is paid.

If payment is made with a bad check, a \$20 fee is added to the forfeiture amount in the dunning letter.

If payment is not received within thirty days, the BRL office manager informs the licensing specialist that the forfeiture was not paid. State law provides that the Department may ask the attorney general to bring an action in the name of the state to collect any forfeiture that has not been paid. However, the more usual approach is to inform the licensee that authority exists under s. 48.66(5), Wis. Stats., to revoke the licensee's license at the point of next license continuation. This usually results in payment of the forfeiture.

When payment is received, the BRL office manager:

- E-mails the licensing specialist and the regional office manager that payment has been received;
- Sends a receipt to the licensee;
- Deposits the payment with the State School Fund.

The licensing specialist must ensure that the payment is entered in CLIC by the responsible data entry staff at the regional office. No entry indicates the payment was not received.

Once the deposit has been made, the BRL office manager forwards copies of the deposit documentation to:

- The licensing specialist for placement in the facility file;
- The licensing chief/deputy;
- The Office of Legal Counsel;
- DCFS files; and
- BRL files.

6. Due Process Related to Forfeitures

To receive an administrative hearing under s. 227.44, Wis. Stats., the person aggrieved must appeal the forfeiture in writing to the Division of Administrative Hearings and Appeals (DHA), Department of Administration, within 10 days of receipt of the notice of forfeiture assessment. The DHA is required to hold a hearing within 30 days after they receive the request unless the aggrieved person consents to an extension of that time.

The Office of Legal Counsel (OLC), Department of Health and Family Services, represents BRL in all contested cases. Often an attorney also represents the facility. The licensing specialist and/or licensing chief/deputy generally participate as a witness in the hearing. For more information regarding the hearing process, see the section on Due Process/Administrative Hearings.

6.1. Forfeiture Payment Following Due Process

When a forfeiture is appealed under s. 48.72, Wis. Stats., payment is suspended until 10 days after the provider receives the final decision from the administrative review; or if the licensee petitions for judicial review under Chapter 227, within 10 days after receipt of the final decision of judicial review. When the final decision upholds the forfeiture, the licensing specialist prepares a notice for the signature of the chief/deputy that informs the provider that payment is now due. Standardized formats of notices to licensed and unlicensed providers are available on the Department's Intranet site. See **Attachment 5**, Unpaid Forfeiture, and **Attachment 6**, Unpaid Forfeiture – Day Care Operation Without a License. The forfeiture is withdrawn if the Department's action is not upheld.

Occasionally, due process may result in a stipulation that allows the licensee to invest the forfeiture amount in meeting a facility need, for example, the purchase of equipment or training rather than paying it to the State.

7. Follow-up Activities

Day care licensees must display the notice of forfeiture (**Attachment 1., 2. or 3.**) beside their license in accordance with s. 48.657(2g), Wis. Stats., until the licensing specialist informs the licensee that it can be removed. For direct forfeitures, this would occur after the forfeiture has been paid, assuming no further violation of the rule that led to the direct forfeiture. When an order has been issued, it would be when the violation(s) cited in the order has been corrected and verified.

If a follow-up inspection verifies that an order has not been complied with by the specified time, or has been violated, a new forfeiture may be assessed. In accordance with s. 48.715(a)1, Wis. Stats., the licensing chief/deputy may set forfeiture amounts that increase, within the statutory limit, if there is continued failure to comply with an order. The licensing chief/deputy may consider moving to a stronger enforcement step for continued non-compliance. These include:

- Suspension of a licensee's license for not more than two weeks;
- Refusal to continue a license or probationary license (i.e. revocation) ;
- Revocation;
- Summary Suspension, if imminent danger exists.

8. Record Keeping

The licensing specialist enters the forfeiture information on the Enforcement Action Sheet and ensures it is submitted to the appropriate regional staff person for data entry into the Children's Licensing Information Computer System (CLIC). For more information on record keeping, see the section titled Record Keeping.
