Chairman Reynolds, Committee Members, Legislators:

As Secretary of the Oak Creek Citizens Action which is trying to cut the cost of government reflected in our confiscatory taxes while maintaining protection of life, liberty and property; and also as 2005 Chairman of the Milwaukee County South Shore Republican Club comprised of the suburbs of Cudahy, South Milwaukee and Oak Creek, that has endorsed this Capital Punishment/Death Penalty; your efforts to revoke the present sentences to our Wisconsin "Lifetime Nursing Home" prison system must be instituted.

South Shore Republican Club - 2005 Resolutions

2005-8. CAPITAL PUNISHMENT

WHEREAS the value a society places on the sanctity of human life can be judged by how severely it punishes the wrongful taking of human life, and

WHEREAS prisoners confined for life are not only a burden to the taxpayers, but also a danger to prison guards and fellow inmates, and

WHEREAS by failing to execute hardened criminals, we are condemning to death their future murder victims,

NOW, THEREFORE, BE IT RESOLVED, by the South Shore Republican Club in caucus assembled, That the death penalty be reinstated for certain heinous crimes, such as first-degree murder, for which any lesser penalty would be an injustice.

End Resolution

The Judeo-Christian injunction pertaining to the Death Penalty/Capital Punishment must be restored:

Deuteronomy XXI: 21. THE PENALTY OF DISOBEDIENCE

And all the men of his city shall stone him with stones, that he die: so shalt thou put evil away from among you; so that all Israel shall hear, and fear.

Murderers, and rapists control many streets in Milwaukee County with impunity. With threats looming for snitchers, drug lords and robbers blossom using children and minors to rob, pillage and steal. No need to work or attend school. If caught and charged, the maximum penalty is "3 hots and a cot" for a lifetime at the "Wisconsin Nursing Home."

Dear Director Schmidt,

the effect Wn SA was state mandated price fixing.

I am requesting a formal investigation to determine whether there is price fixing and/or collusion among Wisconsin gasoline retailers. In particular, I am requesting an analysis of the price uniformity that exists in most Wisconsin cities and may violate Section 1 of the Sherman Act, which pertains to collusive behavior.

A review of gas prices on May 2, 2006, showed the following price uniformity in all of Wisconsin major cities, as compared to other Midwest cities in other states.

Milwaukee: high \$2.999 / low \$2.899 = .10 variance

Madison: high \$2.959 / low \$2.859 = .10 variance

Green Bay: high \$2.959 / low \$2.949 = .01 variance

Kenosha: high \$2.959 / low \$2.899 = .06 variance

Wausau: high \$2.939 / low \$2.899 = .04 variance

Minneapolis, MN: high \$2.909 / low \$2.279 = .63 variance

Springfield, IL.: high \$3.279 / low \$2.849 = .36 variance

Indianapolis, IN.: high \$2.969 / low \$2.669 = .30 variance
