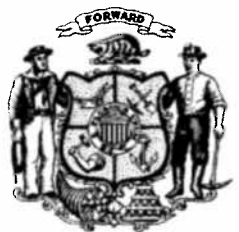

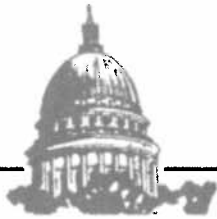

I am writing today to respectfully request a hearing and executive action on Senate Bill 374, which was referred to your committee on October 10, 2005.

This bill directs the Department of Transportation to designate and mark the bridge on State Highway 141 in the Town of Lena in Oconto County as the "Nichole M. Frye Memorial Bridge" in honor and recognition of Nichole M. Frye, who sacrificed her life in Operation Iraqi Freedom.

The Assembly companion, Assembly Bill 755, received a public hearing in November and Chairman John Ainsworth plans to hold an executive session on the bill on February 9th.
