



I read your Press Release of Nov 21, 2002. It truly sounds good but I fear that both sides will have a hard time adopting it. It seems like when there is a change in one house or the other, the "winning" side wants to seek at least some small revenge for what it feels were injustices when THEY were the minority. In any case, good luck. I applaud your efforts.

I am one of the 200 or so appointees whose confirmation was never confirmed by the State Senate due to never having been scheduled for a floor vote by Senator Chvala. I was appointed to the State Board of Veterans Affairs in early fall of 1999. I met Senator Moen's committee shortly thereafter in a very friendly session but the confirmation was never brought to the floor. I again met before Senator Moen's committee in the Spring of this year (a second time!). During this hearing I was lambasted by Senator Moen, Senator Breske and Senator Robson. Of the Democrats on the committee, only Senator Jon Erpenbach was civil.


As a retired USAF colonel who spent almost 6 years in North Vietnam as a Prisoner of War, I don't think I deserved the type of treatment that was given to me by the three Senators during my second confirmation hearing. I have served honorably on the State Board of Veterans Affairs for over three years--in fact I am and have been chairman of the Board since January of this year--almost 11 months. I hope that your influence will help those who are appointed to worthwhile offices continue in their role. If not, I will have been happy to add my guidance to the Board of Veterans Affairs.



Mr. Chairman and Members,

I provide this testimony today as a Veteran, specifically as a combat wounded veteran and the Department Adjutant and elected officer of the Wisconsin Department of the Military Order of the Purple Heart. I am also a member of other veteran's organizations but am not testifying on their behalf and my testimony does not represent their position. In addition my testimony today has no connection whatever with my employment nor am I testifying on behalf of my employer.

Our organization has always championed the independence and non-partisan nature of the Wisconsin Board of Veterans Affairs. In general those confirmed to the Board of Veterans affairs have shunned partisanship in favor of what is right for those veterans who served this nation. In most cases our organization has registered in favor of governor's appointees to the board, regardless of their known political affiliation. We support appointees who will leave their politics outside of the Veterans Affairs Board Room and will set policy on what is best for all veterans.

Today we must object to the appointment of former Senator Rod Moen. We recognize that during his tenure in the legislature and as the long-time Chair of the Senate Veterans Committee, in most cases Senator Moen did what was right for veterans. But as we all know, in most case casting a vote in favor of veterans is not a difficult choice. An individual's true nature can best be assessed by their actions when having to make difficult choices.

Our objection to this appointment is based on a difficult choice Senator Moen made as Chair of the Senate Veterans Committee. We believe that the choice he made speaks volumes about what is truly important to him; his choice was to place partisan politics above his duty as a recognized leader and spokesman for his fellow veterans.

The choice he made was first to hold up the appointment of Patriot Donald Heiliger a member of our organization, for 3 ½ years, before holding a hearing on his appointment in 2003.

I was present at that hearing to testify on behalf of Patriot and American Hero Don Heiliger. In all honesty, I was shocked at the manner in which Senator Moen and some other member of the committee treated this hero of our nation. Patriot Heiliger was and is held in the highest regard by members of the veteran's community. Patriot Heiliger retired as a Colonel from the United States Air Force in 1985, after a 30-year career. He was both a fighter pilot and navigator. In 1967, while piloting an F-105 during the Vietnam War, he was shot down on his 44th combat mission and spent nearly six years as a Prisoner Of War in North Vietnam. The stories about Don's patriotic acts when a POW, have become legend within the combat veterans brotherhood.

Rather than lead a discussion on Patriot Heiliger's background and qualifications to be a board member, Senator Moen instead made the choice to lead a personal partisan attack against Patriot Heiliger. This personal attack was based on a public position Mr. Heiliger had taken on a candidate for state office, prior to his being asked to serve on the Board of Veterans Affairs.

Senator Moen chose to unfairly equate Mr. Heiliger's activity as a private citizen as an indicator that Mr. Heiliger was a partisan appointee and thus was not an appropriate candidate for the board.

As a veteran himself we find it difficult to believe that Senator Moen would have chosen to lead this unfair and uncalled for partisan attack against Patriot Heiliger without outside influence.

We feel that Senator Moen's actions on that day demonstrate that his choices have been and can be influenced by partisanship. The Military Order of the Purple Heart champions the independence and non-partisan nature of the Wisconsin Board of Veterans Affairs. Therefore we cannot in good conscience support this nomination.
