





# *It Takes a Hospital*



**St** JOSEPH'S

**A** community is made up of many things, but, it is noticeably incomplete without the presence of a hospital. It takes a hospital to breathe new life in to a community as the littlest and most vulnerable are welcomed. Quality of life is strengthened as it takes a hospital to provide, on a daily basis, the emergency care, surgical expertise and rehabilitative therapies that a community's families need at a moment's notice. And, it takes a hospital to provide comfort and support at life's end through intensive care technology and the gentle extended hand of home health and hospice care.

**W**hile it takes a hospital to complete a community, in turn, it takes a community to assure that its most pivotal of healthcare services are not diminished and inaccessible to those in most desperate need. A hospital is only as capable and effective as the willingness and support shown by its community to assure healthcare is never compromised for any individual. This mutual partnership and dedication to service creates a complete community in which everyone benefits.

### *Duane's Story*

**D**uane Hennekens no longer wanted to remain in the hospital. He wanted to be in the comfort of his own home surrounded by everyone and everything most dear. After eight months of battling cancer, Duane and his family knew that his journey was coming to an end. Duane and his wife, Debra, met with the Hospice Team at St. Joseph's Hospital and began planning for his care. They made his return home comfortable by planning his transportation, arranging for a hospital bed, monitoring his medications and pain, and anticipating his every need. Duane and Debra understood that his cancer was no longer manageable and that Hospice would assist with the emotional trauma ahead.

**W**ith openness and honesty they explained what was happening to his body. They brought him peace by helping him face his fear of dying. With amazing dedication and compassion the Hospice Team brought the family to a place of peace and acceptance. They became "Earth Angels." As Duane's final day approached, the Hospice nurse was by the family's side. Consumed with their final goodbyes, the family relied on the hospice nurse to guide them to the end. When Duane's time arrived the family found the strength to let him go. In the days, weeks and months ahead, the Hospice Team continued their support by helping family members cope with their grief. The kindness and support of the Hospice Team continues to live in the hearts of those who loved and lost, Duane Hennekens.

### *Owen's Story*

Forty to fifty babies are born at St. Joseph's Hospital each month. When Owen Geissler was born in 1995 something went terribly wrong. Owen quit breathing. His condition was diagnosed with amazing speed and accuracy and the infant was airlifted to two different hospitals before receiving his life-saving heart surgery. Although surgery repaired the arteries to Owen's heart, his prognosis wasn't encouraging. Most children with his condition don't survive, but specialists in Marshfield and Milwaukee credit St. Joseph's Hospital and his doctor in Chippewa Falls with saving his life.

Jennifer and Scot Geissler, Owen's parents, were astounded at the level of responsiveness. "Thank goodness the staff trusted their instincts," says Jennifer. "At St. Joe's it's more than just text book learning. It's about people. Patients are not just numbers; they have names. And they called my son, Owen."

### *Evelyn's Story*

From the terrifying accident that brought her to St. Joseph's Hospital, to the birth of her daughter, Jennifer Willi credits St. Joseph's Hospital for the "little things" that make a difference. The day Jennifer Willi learned of her pregnancy was the day she was in a serious auto accident. Upon arriving at the Emergency Center, Jennifer was met with "kindness, comfort and reassurance." While she prepared for the worst (losing her baby) worry entered her every day life. Through a series of complications and after three weeks, Jennifer and her husband received the good news. A heartbeat was detected and the baby was alive! On July 16, 2005 Evelyn Willi was born. "I cannot explain the emotion that I felt as I held my baby for the first time or when I saw the way my husband looked at our new daughter," says Jennifer. "Everyone on the surgical team and everyone from the Birth Center treated us like we were the only patients they had. It was the "little things," the "small details" that made the Willi's experience so exceptional. As Jennifer sums it up, "It was truly an honor to have our baby at St. Joseph's Hospital."

# *Community Benefit*

**N**ot-for-profit hospitals have a rich tradition of providing benefit to their communities. Hospitals are planned, developed and maintained to meet community needs for healthcare, not because of economic opportunity. Today, responding to community need has gone far beyond listening to a voiced need, raising funds to meet that need and then actually providing services to meet the need. Hospitals are now often taking a leadership role in their community conducting needs assessments, paying particular attention to the needs of the poor and others who are underserved and lack access. St. Joseph's Hospital partners with community groups to identify needs, strengthen existing community programs and plans for new services to meet the healthcare needs of our residents. St. Joseph's provides an array of community benefit services designed to improve community health and the health of individuals and to increase access to health care. St. Joseph's Hospital provides free and discounted services to people who are uninsured and underinsured.

**G**enerally, five categories of activities are commonly associated with community benefit:

- community health education and prevention services
- health professional's education
- subsidized health services
- research
- financial contributions



**H**owever, the community benefit role of hospitals, especially not-for-profits like St. Joseph's, is increasingly challenging. Complex organizational structures, predatory competitiveness and financial constraints have demanded that a proactive community benefit strategy replace the spontaneous community benefit programs carried out by our predecessors. Community benefit strategies are a planned, managed and measured organizational approach to meeting and reporting identified community health needs and improving community health.

**S**t. Joseph's Hospital will direct its efforts towards community benefit that is highly focused and responsive to meeting identified community health needs. We will promote collaboration with our "community" to "benefit" our residents, especially the underserved and those lacking access, by improving health status and quality of life.

# Benefits for the Poor

**E**mbracing the heritage of our founders - the Hospital Sisters of the Third Order of St. Francis, St. Joseph's Hospital provides care for all people, regardless of their financial resources and abilities to pay for the care and services they receive. St. Joseph's Hospital benefits our community by assuring health care is accessible to everyone.

**\$4,986,106\*** - Free care to the poor, donations to the needy and Medicaid program underpayments, which showed for a \$100 bill, Medicaid paid our hospital \$21.49

**\$20,965,775** - Additionally, Medicare program beneficiaries includes charges the hospital is required to meet in order to pay the difference of the patient bill the government will not pay (\$59.80 for every \$100), this amount cannot be rebilled to the patient under law.

# *Benefits for Community Education and Prevention Services*

**I**t takes a special hospital, like St. Joseph's, to be a leader in providing healthcare education and community service.

**\$569,664** - Free health screenings, health information and instruction, support groups  
community speakers.


**A**dditionally, the hospital provides free on-campus space to house a rural dental clinic that provides care to hundreds of at risk patients of all ages. Our hospital contributes truckloads of supplies, including equipment no longer used in our facility, to help our Sister sponsors continue their mission outreach activities throughout the third world. Linens, office supplies, lab equipment and others are routinely sent to serve those in need.

# Benefits for Professional Education

Numerous healthcare professionals require on-going education and training to remain actively certified in their profession. St. Joseph's Hospital offers the professional education programs that are needed.

**\$24,072** - Includes inservice and training programs for health professionals. Examples include Pediatric Advanced Life Support (PALS) training, nursing skills training and monthly lectures in the field of mental health, alcoholism and drug abuse issues.

St. Joseph's Hospital also has teaching agreements with numerous colleges, universities, technical colleges in Wisconsin and Minnesota to offer on-site training for nursing, dietetics, rehabilitation, social work, pharmacy and counseling students. Scholarships are also awarded by the hospital's Partners organization to area students who are enrolled and accepted in a health-related career field.
