3 "SECTION 50m. 77.51 (4) (b) 6. of the statutes is amended to read:

4 77.51 (4) (b) 6. Thirty-five percent of the sale price of a new mobile home that
5 is a primary housing unit under s. 340.01 (29) or of a new mobile home that is
6 transported in 2 unattached sections if the total size of the combined sections, not
7 including additions and attachments, is at least 984 square feet measured when the
8 sections are ready for transportation manufactured home, as defined in s. 101.91
9 (11). No credit may be allowed for trade-ins under subd. 3. or sub. (15) (b) 4. This
10 subdivision does not apply to lease or rental."

11 2. Page 21, line 6: delete lines 6 to 10 and substitute:
