March 9, 2006 - Introduced by Representative PARISI, cosponsored by Senator MILLER, by request of Charles Onsum. (Referred to Committee on Transportation.

AN ACT to amend 346.02 (1) of the statutes; relating to: the applicability of rules

of the road to private roads located in mobile home parks.

Analysis by the Legislative Reference Bureau

Under current law, rules of the road apply upon highways, with certain Current law defines "highway" to include all public ways and exceptions. thoroughfares and bridges on the same. Highway includes roads or driveways in parks and in state forests that are open to the public and roads or driveways that are on the grounds of public schools and under the jurisdiction of the county. However, a private road or driveway is not considered a highway.

This bill applies all of the rules of the road to private roads that are located

within mobile home parks.

SECTION 1. 346.02 (1) of the statutes is amended to read: 3

346.02 (1) APPLIES PRIMARILY UPON HIGHWAYS. This chapter applies exclusively

upon highways and private roads that are located within mobile home parks, as

defined in s. 66.0435 (1) (e), except as otherwise expressly provided in this chapter.
