2. Page 2, line 1: before that line insert:
"SECTION 1e. 13.08 of the statutes is repealed."

3. Page 2, line 1: delete "SECTION 1" and substitute "SECTION 1r".

4. Page 2, line 15: after that line insert:

"SECTION 2b. 13.123 (1) of the statutes is repealed.

SECTION 2d. 13.123 (3) of the statutes, as affected by 2007 Wisconsin Act 1, is repealed.

SECTION 2f. 13.15 (2) (b) of the statutes is repealed and recreated to read:

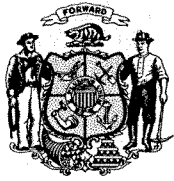
