


The Committee on Ways & Means would like the bill amended to require Departments to provide base budget reviews:

- In the same format as previous base budget reviews; or
- If in a new format is employed for new base budget reviews, then previous base budget reviews must be provided in the new format as well

The Fiscal Bureau would like the bill amended to require:

- Have SS16.423 Base Budget Review reports included in the documents required under SS16.43
- Have SS16.42 (1) (b) statements included in the documents required under SS16.43

1 **AN ACT ...; relating to:** base budget review reports. ✓

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

2 **SECTION 1.** 16.423 (5) <sup>x</sup> of the statutes is created to read:

3 16.423 (5) Notwithstanding sub. <sup>✓</sup>(4), a state agency may use any format for its  
4 report. <sup>✓</sup>If a state agency uses a format for a report that is different from the format  
5 that the state agency used for one or more previous reports, the state agency shall  
6 reissue all previous reports in the new format. <sup>✓</sup>

7 **SECTION 2.** 16.43 <sup>x</sup> of the statutes is amended to read:

8 **16.43 Budget compiled.** <sup>✓</sup> The secretary shall compile and submit to the  
9 governor or the governor-elect and to each person elected to serve in the legislature  
10 during the next biennium, not later than November 20 of each even-numbered year,  
11 a compilation giving all of the data required by s. 16.46 to be included in the state  
12 budget report, except the recommendations of the governor and the explanation

1       thereof. The secretary shall not include in the compilation any provision for the  
2       development or implementation of an information technology development project  
3       for an executive branch agency that is not consistent with the strategic plan of the  
4       agency, as approved under s. 16.976. The secretary may distribute the budget  
5       compilation in printed or optical disk format. As part of the budget compilation, the  
6       secretary ✓ shall also submit the most recent base budget review reports under s.  
7       16.423 ✓ for each state agency and the most recent statements submitted under s.  
8       16.42 (1) (b) ✓ for each state agency.
