

ASSEMBLY AMENDMENT I,  
<sup>2007</sup>  
TO 2005 ASSEMBLY BILL 66 61

May 26, 2005 - Offered by COMMITTEE ON CAMPAIGNS AND ELECTIONS.

1 At the locations indicated, amend the bill as follows:

2 ✓ 1. Page 1, line ~~10~~<sup>2</sup> after "officials" insert ", officials elect,".

3 ✓ 2. Page 2, line ~~10~~<sup>2</sup> delete "or" and substitute ", including the governor and  
4 lieutenant governor, and no".

5 ✓ 3. Page 2, line ~~8~~<sup>7</sup> after that line insert:

6 "(b) No individual who is serving as governor or lieutenant governor, no  
7 individual who has been elected to the office of governor or lieutenant governor but  
8 has not yet taken office, and no personal campaign committee or support committee  
9 authorized under s. 11.05 (3) (p) of any such individual may accept any contribution  
10 for the purpose of promoting that individual's nomination to or reelection to the office  
11 held by the individual beginning on the day after the date of the general election and

12 ending on the succeeding first Monday in January. For purposes of this paragraph,  
13 the ~~executive director~~<sup>legal counsel to</sup> of the board shall determine, on the basis of media reports, if

1 it is generally acknowledged that an individual has been elected to the office of  
 2 governor or lieutenant governor, and shall inform in writing any individual who<sup>m</sup> the  
 3 ~~executive director~~ <sup>legal counsel</sup> determines to have been so elected as soon as the ~~executive~~  
 4 ~~director~~ <sup>legal counsel</sup> makes such a determination. In making his or her determination, the  
 5 ~~executive director~~ <sup>legal counsel</sup> is bound by the certification of the chairperson of the board or his  
 6 or her designee if the certification has been issued.”.

- 8 √ **5.** Page 2, line ~~160~~ <sup>15</sup> after “official” insert “, official elect,”.
- 9 √ **6.** Page 2, line ~~170~~ <sup>16</sup> after “official” insert “or official elect”.
