ASSEMBLY AMENDMENT,

TO 2007 ASSEMBLY BILL 61

At the locations indicated, amend the bill as follows:

- 1. Page 1, line 3: after "committees" insert "and providing a penalty".
- 2. Page 2, line 18: after that line insert:

"Section 37. 11.61 (1) (c) of the statutes is amended to read:

11.61 (1) (c) Whoever intentionally violates any provision of this chapter other than <u>s. 11.24 (4)</u> and those provided provisions specified in par. (a) and whoever intentionally violates any provision under par. (b) where the intentional violation concerns a specific figure which does not exceed \$100 in amount or value may be fined not more than \$1,000 or imprisoned not more than 6 months or both.".
