

For Rep. Albers' amendment to AB 61 that requires that candidates not fundraise during the budget process, Rep. Albers wants to define "candidate" in terms of an individual that has an "active campaign account," that is, they have not necessarily announced their intention to run but are raising funds to do so. This would include individuals who ran for an office and lost but still have an active campaign account because they are considering another run.
