This bill prohibits the Department of Administration (DOA), any agency to which DOA delegates purchasing authority, or any authorized legislative and judicial officer from entering into any contract or order to purchase materials, supplies, equipment, or services with an entity unless the entity maintains at least one telephone line that is staffed during its regular business hours by an individual who is able to respond to business inquiries.
