2 (am) of the statutes; **relating to:** publication of municipal legal notices. ✓

Analysis by the Legislative Reference Bureau

Current law requires a municipality, including a county, city, village, town, or school district, to publish a legal notice in a newspaper with paid circulation that is likely to give notice in the area or to the person affected. Generally, this means a newspaper that has at least two years of publication experience in the municipality and a paid circulation of at least 50 percent of its total circulation.

The bill allows a municipality the additional options of ~~1) publishing the legal notice in a free "shopper newspaper" if the newspaper has been published continuously for at least one year and the publisher leaves at distribution points in the county in which the publisher is headquartered or in which the newspaper is published enough copies for 10 percent of the county's residents; or 2) posting the notice on the Internet site of the municipality.~~ ✓
