


**ASSEMBLY SUBSTITUTE AMENDMENT ,
TO 2007 ASSEMBLY BILL 170**

1 AN ACT ...; relating to: publication of municipal legal notices. ✓

Analysis by the Legislative Reference Bureau

Under current law, a municipality may publish a legal notice in a newspaper likely to give notice in the area or to the persons affected or the municipality may post the legal notice in at least three ✓ public places likely to give notice to the persons affected by the content of the legal notice.

* This bill provides that the Internet ✓ may be one of the three ✓ public places ^{that} a municipality may post a legal notice if the municipality elects to use that method of posting a legal notice. ✓

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2 SECTION 1. 985.02 (2) (a) ✓ of the statutes is amended to read:

3 985.02 (2) (a) The notice must be posted in at least 3 public places likely to give
4 notice to persons affected. In this paragraph, the Internet ✓ is considered a public
5 place. ✓

6 (END)
