- AN ACT to create 40.02 (39u) and 40.08 (2e) of the statutes; relating to:
- 2 deduction of membership dues from retirement annuities under the Wisconsin
- 3 Retirement System.

## Analysis by the Legislative Reference Bureau

Wisconsin Retirement System annuitants may not currently authorize the Department of Employee Trust Funds (DETF) to deduct from their retirement annuities any membership dues to a labor organization, professional organization, or a retiree organization affiliated with a labor organization or professional organization. This bill authorizes DETF to make such deductions.

This bill will be referred to the Joint Survey Committee on Retirement Systems for a detailed analysis, which will be printed as an appendix to this bill.
