


Hi Robin,

Would you be able to draft an amendment to AB 187 or a substitute amendment if it works better that changes the fees to \$11.25 for both residents and nonresidents (for a total of \$12 for each license)? Also include a three year sunset of this bill to include three full fishing seasons after the day this bill is enacted. Assuming this bill will be enacted before April of this year, include 2008-09, 2009-10, and 2010-11. Also, require DNR to provide a report to the Assembly and Senate Natural Resources Committees by January, 2011 outlining the effect of one-day fishing licenses.

Analysis by the Legislative Reference Bureau

Under current law, with certain exceptions including an exception for residents under the age of 16, no person may fish in this state unless the person has a valid approval that authorizes fishing. The Department of Natural Resources (DNR) issues various fishing licenses including resident and nonresident annual fishing licenses, two-day sports fishing licenses for both residents and nonresidents, 15-day fishing licenses for nonresidents, and four-day fishing licenses for nonresidents. This bill requires DNR to also issue one-day fishing licenses to residents and nonresidents.

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

SECTION ~~I~~ **I. Nonstatutory provisions.**

(1) The department of natural resources shall evaluate the effect of issuing one-day fishing licenses under ^{sections} ss. 29.219 (2m) and 29.228 (4m) of the statutes, as created by this act, and prepare a report on that evaluation. The department of natural resources shall submit the report no later than November 1, 2010 to the chief clerk of each house of the legislature, for distribution to the appropriate standing committees under ^{section} s. 13.172 (3) of the statutes.
