

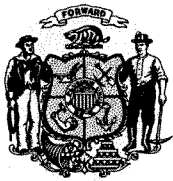
Debora:

5 "SECTION 1g. 146.89 (1) (r) of the statutes is amended to read:

6 146.89 (1) (r) "Volunteer health care provider" means an individual who is
7 licensed as a physician under ch. 448, dentist or dental hygienist under ch. 447,
8 registered nurse, practical nurse, or nurse-midwife under ch. 441, optometrist
9 under ch. 449, or physician assistant under ch. 448, or ~~chiropractor~~ under ch. 446,
10 who is certified as a dietitian under subch. V of ch. 448, or who is a nurse practitioner,
11 as defined in s. 255.06 (1) (d), and who receives no income from the practice of that
12 health care profession or who receives no income from the practice of that health care
