**ASSEMBLY AMENDMENT ,
TO 2007 ASSEMBLY BILL 282**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 3: delete “Whoever intentionally causes bodily harm or
3 threatens” and substitute “~~Whoever intentionally causes~~ No person may
4 intentionally cause bodily harm or threaten”.

5 **2.** Page 2, line 7: delete “under all of the following circumstances is guilty” and
6 substitute “~~is guilty~~”.

7 **3.** Page 2, line 8: delete “of a Class I felony:” and substitute “~~of a Class I felony.~~
8 under all of the following circumstances:”.

9 **4.** Page 2, line 18: after that line insert:

10 “**SECTION 4m.** 940.20 (5) (c) of the statutes is created to read:

11 940.20 (5) (c) 1. A person who intentionally causes bodily harm in violation of
12 par. (b) is guilty of a Class I felony.
