

This ~~substitute amendment~~ prohibits charging for motor vehicle fuel a wholesale or retail price that grossly exceeds the price at which motor vehicle fuel is sold by another or that grossly exceeds the average price at which motor vehicle fuel was sold in the 12-month period immediately preceding a sale of the motor vehicle fuel. Under the ~~substitute amendment~~, the attorney general investigates violations of, and enforces, the provisions of the ~~substitute amendment~~.
