Cathlene,

Can I get an amendment drafted for AB 424 that:

The bill then requires notice of these orders, as well as any cancellation of these orders, to be reported for purposes of the firearms restrictions record search and to have the department of justice "promulgate rules to convey information in a timely manner to the national instant criminal background check system regarding persons ordered not to possess a firearm [under the provisions discussed generally, above.]" I would prefer this also include cancelled orders and suggest the following line be added to the end of this proposed **Section 12** of the Bill: "... as well as the cancellation of any such order." This may be a bit redundant given some other provisions of the bill, but since this is a provision to specifically require certain rules be created, I would prefer this be included as well. It would not conflict with any other provision or spirit of the bill so hopefully it would be met with no objections.

SECTION 12. 175.35 (2g) (d) of the statutes is created to read:

175.35 (2g) (d) The department of justice shall promulgate rules to convey information in a timely manner to the national instant criminal background check system regarding persons ordered not to possess a firearm under s. 51.20 (13) (cv) 1., based on a determination under s. 51.20 (13) (cv) 1. b., or ordered not to possess a firearm under s. 51.45 (13) (i), 54.10 (3) (f), or 55.12 (10).
