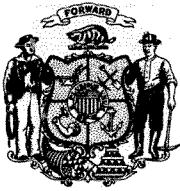

**Analysis by the Legislative Reference Bureau**

This bill requires all state agencies to designate March 31<sup>✓</sup> as "Cesar E. Chavez Day" in observance of the birthday of Cesar E. Chavez. Under the bill, if March 31 falls on a day on which the offices of a state agency are open, the appointing authority of the state agency is required to permit any employee of the state agency to receive that day as a paid holiday in lieu of receiving a paid holiday on one of the other paid holidays provided to state employees. The bill also provides that the appointing authority may permit an employee to receive March 31 as a paid holiday only if the operations of the state agency are maintained at least at a minimum level. The bill's provisions apply to nonrepresented state employees and will only apply to represented state employees if so provided in applicable collective bargaining agreements.

**The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:**

## ASSEMBLY BILL 283

## SECTION 1

1           **SECTION 1.** 230.35 (4) (b) <sup>x</sup> of the statutes is renumbered 230.35 (4) (b) 1. and  
2 amended to read:

3           230.35 (4) (b) 1. ~~Compensatory~~ <sup>✓</sup> Except as provided in subd. 2., compensatory  
4 time off or payment, either of which shall be at the rate of time and one-half, shall  
5 be granted to state employees for all work performed on the holidays enumerated in  
6 par. (a) 1. to 9.

7           **SECTION 2.** 230.35 (4) (b) 2. <sup>x</sup> of the statutes is created to read:

8           230.35 (4) (b) 2. Subdivision 1. <sup>✓</sup> shall not apply to work performed by a state  
9 employee on a holiday enumerated in par. (a) 1. to 9. <sup>✓</sup>, if the state employee received  
10 a paid holiday for March 31 and the work is performed on the holiday to make up for  
11 receiving a paid holiday on March 31.

12           **SECTION 3.** 230.35 (4m) <sup>x</sup> of the statutes is created to read:

13           230.35 (4m) (a) All agencies shall designate March 31 <sup>✓</sup> as "Cesar E. Chavez  
14 Day" in observance of the birthday of Cesar E. Chavez.

15           (b) <sup>✓</sup> If March 31 falls on a day on which the offices of any agency are open, the  
16 appointing authority of the agency shall permit any employee of the agency to receive  
17 that day as a paid holiday in lieu of receiving a paid holiday on one of the holidays  
18 enumerated in sub. <sup>✓</sup> (4) (a), but only if the operations of the agency are maintained  
19 at least at a minimum level.
