At the locations indicated, amend the bill as follows:

1. Page 2, line 2: delete "The" and substitute "(a) Except as provided in par.

(b), the" department

2. Page 2, line 7: after that line insert:

"(b) The department is not required to publish the notice specified under par. (a) if a zoning ordinance requires the publication of a notice of the proposed construction of a liquefied petroleum gas installation that uses containers of 15,000 gallons or larger water capacity."
